### SUMMARY

- Participate in special projects related to hedge fund strategies or broader industry knowledge.
- Write research reports on European hedge fund strategies and various aspects of the alternative investment industry as well as prepare specific investment case studies for review and discussion.
- Periodic travel for meetings and conferences will be required.
- Perform special projects related to the Europe strategy or hedge fund industry.
